Hostel Rules & Regulations

- 1. 50% Fees at the time of admission and balance 50% within four months or start of second semester.
- 2. Students can pay the hostel fees by Payment Gateway/NEFT/Net Banking/DD/Google/Phone Pay
- 3. Cheque /Cash will not be accepted at any circumstances.
- 4. Admission cancelled within two months may be considered for refunds and no refunds will be considered after two months.
- 5. Cancellation charges for hostels will be Rs. 5,000/-, If cancellation is done within two months.
- 6. Bed, Cupboard, will be provided.
- 7. Electricity Bill should be below or up to 1,000/- (above 1,000/- will be deducted from deposit amount), Internet (Wi-Fi), and housekeeping facility will be provided.
- 8. Solar Hot water will be provided only during 6.00 a.m. to 8.00 a.m.

9. Mess Facility will not be provided for the Girls Hostel

- 10.Laundry service will not be provided.
- 11. Friends, parents and guests are not allowed to stay in the hostel.
- 12. The student will be held responsible and will be fined if he/she damages any furniture or fixture in the room or of the hostel premises.
- 13.In case of illness or any other emergency, the Students should immediately report to the Principal / Director for further appropriate action. All expenses related to medical treatment will be borne by the student.
- 14. If student is leaving the flat for any reason for one or more than one night, he/she shall have to inform Principal in writing. Permission Letter duly

- signed by the principal/Director is mandatory. In absence of written permission, the College will not
- 15.be responsible for any incidence concerning safety.
- 16. Smoking, chewing tobacco or pan, spitting as well as consuming alcoholic drinks is strictly prohibited. In case of violation of the rule in hostel or campus, the student will be rusticated from hostel immediately. In that case hostel fee will not be refunded.
- 17. Misbehavior with security guards/watchman/ mess staff/Waiters/ or any other official of the hostel will be treated as an act of indiscipline.
- 18. Any suggestion regarding the improvement in hostel facilities should be made to the hostel rector in writing.
- 19. Ragging of any sort is strictly prohibited & strict action will be taken against the culprit.

Ragging is strictly prohibited. The Maharashtra Legislative Council has passed a bill (LC Bill Number ix of 1999) to prohibit ragging in educational institutions in the State of Maharashtra on 7thApril 1999. As per this bill –

- Ragging within or outside of any educational institution is strictly prohibited.
- Whosoever directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution shall on conviction. be punished, as per the rules.
- Any student convicted of an offence of ragging shall be dismissed from the educational institution and such student shall not be admitted to any other educational institution for a period of five years from the date of order of such dismissal.
- 1. It is mandatory to pay 50% hostel and mess fees at the time of admission. The balance 20% has to be paid after three months and balance 30% has to be paid after six months from the beginning of the academic year.

- 2. Any type of RAGGING is strictly prohibited. Action as per ragging act will be immediately taken on notice of such act.
- 3. Hostel administration reserves the right to deny admission or cancel admission at any stage.
- 4. Local Students are not eligible for Hostel Admission.
- 5. Students should keep their room neat and clean.
- 6. Students should take prior approval from the rector/ warden before remaining absent from the hostel, whether to go home or local guardian.
- 7. Absence from hostel without permission is liable to heavy fine and punishment.
- 8. The students involved in common off shall be detained if there is shortage of attendance as prescribed by the rules of institute. Further he/she will be expelled from the hostel.
- 9. Room occupies will ensure that their room is free from pornographic literature, films, CDs, etc. If any of these are found in room, all room occupants will be held responsible.
- 10. Timings for Boys hostel: 5.00 am to 10.00 pm Timings for Girls hostel: 6.00 am to 08.30 pm After these timings all Students will not be allowed to enter the hostels without permission of hostel authorities
- 11. If the student damages any Hostel property (like wash basin, furniture, Electrical equipment, walls etc.) the loss will be recovered.
- 12. It is mandatory for girl students to take a written permission from Warden/Rector for any absence in hostel during night hours (i.e. outstation stay). If any girl student disobeys this rule, a heavy fine will be imposed first time and student will be immediately expelled from the hostel, if it is repeated second time.
- 13. During stay in hostel campus tobacco consumption (i.e. Ghutka, Pan masala, smoking etc.) and any alcoholic consumption is strictly prohibited. Any complaint regarding alcohol consumption and nuisance by a concerned student will be considered seriously and the student will be expelled

- from the hostel, and he/she will have to appear before Institute Disciplinary Committee.
- 14. No guests are allowed to stay in hostel without permission of the Warden/Rector. Guest charge is Rs. 50/- per day per person. If any outsider is found in the room without permission, the students will be held responsible and such students will be expelled from the hostel.
- 15. Once room is allotted to a student, he/she is not allowed to change the room in any circumstances, without prior permission of the Rector/Warden. If found, strict action will be taken
- 16. Water and electricity should be used economically, Use of electrical appliances e.g. Heater, rod, stove, kettle, iron, hot plate etc. is strictly prohibited. Heavy fine will be charged if the students are found using such appliances and they will be liable for dismissal from the hostel.
- 17. Students should switch off the light and fan while going out of the room.
- 18. Students of hostel should obey the rules set up by the mess-committee to maintain discipline in the mess hall. Mess fees has to be paid in the beginning. Only hostel students are permitted to avail the facility of mess. No guests or outsiders are permitted to take meal in the mess without the prior permission of Rector/ Warden and mess committee, if permitted they have to pay prescribed mess charges.
- 19. The jewellery, money lap-top, mobile etc. (costly items) should be kept in safe custody, on student's own risk. The authority holds no responsibility for the theft or loss.
- 20. Do not keep your keys on the door frames etc. or handover to your friends.
- 21. The right to frame new rules, if required, is reserved with the authority to maintain peaceful, secured and a healthy atmosphere in the hostel premises.
- 22. If anybody is found disobeying instructions of security guard, misbehaving in the hostel premises or college premises or on road, which will damage the image of the institute, he/she shall be punished and may be expelled from the hostel permanently.

- 23. The decision of the Rector shall be final on the matters pertaining to the hostel.
- 24. Misuse of internet facility in the hostels will attract severe punishment.
- 25. Hostel administration is not responsible for loss of any personal belongings of hostel students (e.g. money. mobile. laptop. books, calculator, ornaments etc.)
- 26. Any kind of in-disciplinary behaviour (e.g. shouting, writing on walls, playing outdoor games in hostel premises throwing paper etc through windows. damage of hostel properties) in hostel premises strictly prohibited.

Ragging is strictly prohibited

The Maharashtra Legislative Council has passed a bill (LC Bill Number ix of 1999) to prohibit ragging in educational institutions in the State of Maharashtra on 7^{th} April 1999. As per this bill –

Ragging within or outside of any educational institution is strictly prohibited. Whosoever directly or indirectly commits, participates in, abets or propagates ragging within or outside any educational institution shall on conviction. be punished, as per the rules.

Any student convicted of an offence of ragging shall be dismissed from the educational institution and such student shall not be admitted to any other educational institution for a period of five years from the date of order of such dismissal.

WARNING

'RAGGING' of students, physically or mentally, is a black spot on the society and is a cognizable offence. The students who have to face ragging can lose their mental stability and can spoil their lives. All the students are requested not to do such inhuman & cruel act and should give up completely.

If any student, is found involved in ragging of juniors or any student, then matter will be handled very seriously. The student may be rusticated and the case may be handed over to the Police. The students should take a serious note of this and act accordingly.
