## **ANTI-RAGGING COMMITTEE**

### **(-----Roles and Responsibilities-----)**

An anti-ragging committee at DYPCOEI is responsible for preventing, monitoring, and eliminating ragging by implementing UGC/AICTE guidelines. Key roles include conducting awareness campaigns, holding surprise raids in hostels and campuses, investigating complaints, counselling victims, and enforcing strict disciplinary actions against offenders.

#### **Key Roles and Responsibilities:**

- **Preventive Measures:** Organizing workshops, seminars, and awareness campaigns for students and parents regarding the legal, physical, and psychological consequences of ragging.
- **Active Monitoring:** Conducting surprise raids and keeping strict vigil in potential hotspots like hostels, canteens, and classrooms
- **Handling Complaints:** Setting up complaint boxes, helplines, or digital channels to receive complaints, and investigating them promptly.
- **Action & Discipline:** Taking immediate disciplinary action—such as suspension or expulsion—against students found guilty of engaging in or abetting, directly or indirectly, any form of ragging.
- **Support System:** Providing counselling and emotional support to victims of ragging.
- **Policy Implementation:** Ensuring all anti-ragging policies, such as mandatory affidavits from students and parents at admission, are enforced.
- **Frequency of meeting:** Twice in a year & unplanned one depending upon the seriousness of any case
